### President's Report – David Hunt

**Caucus Committee Meeting called to order:** The meeting was called to order at 7:03 pm by David Hunt, President. A quorum was in attendance.

Scott Anderson made a motion to approve the minutes from the 3/14/2023 meeting, and Michelle Parnel seconded the motion. The Caucus Committee voted to approve the minutes.

#### Removal of a Caucus Committee Member – David Hunt

David Hunt read section 6.09 of the Lake Forest Caucus bylaws regarding the removal of a Caucus Committee member. He went on to explain that in an Executive Session on Zoom on the evening of April 6th, the Executive Committee voted unanimously by those in attendance, with the exception of Phil himself, to remove Phillip Arouca from the Caucus Committee for violation of confidentiality policies and procedures, as well as a clear conflict of interest in campaigning against the Caucus Mayor candidate after repeatedly asking for Phil's resignation. Phillip Arouca requested to appeal this vote during the full Caucus Committee meeting held on April 11th.

#### Deliberation

The Caucus Committee deliberated on the removal of Philip Arouca, Ward 2 Chair from the Lake Forest Caucus Committee for the 2022-2023 year. Philip Arouca presented a statement in his defense. Several Caucus Committee Members expressed their views on the removal of Philip Arouca. Philip Arouca made a number of responses. Chris Benes made a motion to vote to remove Philip from the Caucus Committee and Steve Murphy seconded the motion. The Caucus Committee took a vote to remove Philip Arouca from the Lake Forest Caucus Committee for violation of well-established confidentiality policies and procedures, which Philip himself admitted to knowing and breaking during deliberations, as well as material conflicts of interests as noted in Section 6.09, including but not limited to campaigning against the Caucus Committee Mayor candidate. The motion passed 29-6.
